

AUGUST 1ST, 2023 FORMULARY UPDATE

Formulary Changes

The following products were added to the formulary:

1. Additions to Tier 2
 - a. Omniflex Vaginal Diaphragm
2. Additions to Tier 4 with PA (pending market release)
 - a. Jesdurvoq 1mg, 2mg, 4mg, 6mg and 8mg Tablets

The following products have changed formulary status:

1. Step Therapy Removed
 - a. Eszopiclone 1mg, 2mg and 3mg Tablet
 - b. Zolpidem Tartrate Extended Release 6.25mg and 12.5mg Tablet
2. Step Therapy Protocol Change
 - a. The following products require prior use of one of the following: zolpidem/zolpidem ER, zaleplon, OR eszopiclone
 - i. Ramelteon 8mg Tablet
 - ii. Belsomra 5mg, 10mg, 15mg and 20mg Tablet
 - iii. Dayvigo 5mg and 10mg Tablet
3. Prior Authorization Removed
 - a. Oxymorphone 5mg and 10mg Tablet

The following products will be removed from the formulary:

1. Endocet 5-325mg Tablet
